Courtney was a member of the Forest Edge Special Ed team and worked tirelessly with her students to help them succeed. After being diagnosed with small cell carcinoma of the ovary in July 2009, she fought a brave, tenacious battle, which she lost just 3 months later. During her short 24 years, Courtney proved to be an accomplished runner, becoming captain on the Herndon High School track team. The students and staff of Forest Edge continue to remember Courtney through this living memorial.

Funds raised will support Forest Edge students, special education initiatives, as well as providing a scholarship to a local high school track athlete in Fairfax County.
